Secretary's Minutes for FEBRUARY 2022

Clear Creek Republican Women General Meeting La Brisa Cantina February 4, 2022

- Call to Order:** President Roxann Lewis called the meeting to order at 12:01
- Invocation:** Given by Nisha Roady- Chaplain
- Pledges:** Led by Sterling and Walker Long
- Welcome and Introductions:** Roxann Lewis had elected officials and candidates introduce themselves, followed by recognizing guests.
- Approval of Minutes:** Minutes were approved as circulated by newsletter.
- Treasurers Report:** Lillian Murphy reported our total balance from Texan bank is \$22,570.71.
- Budget:** Lillian Murphy discussed the 2022 budget which included \$20,930.00 for projected expenses and with current income sources the projected end of year balance should be \$7,704.52.
- Membership:** Barbara Meeks reminded members that dues are ready to be paid. She reported 51 full members and 29 associate members.
- Programs:** Kristen Day introduced the forum, which was for the candidates of two positions: the Galveston County Treasurer and Galveston County Court of Law #2. Candidates for County Treasurer included Kevin Walsh, Hank Dugie, and Janet Hoffman. Candidates for County Court at Law #2 included Tot Le and Kerri Foley. Kristen stated the guidelines for the forum and informed the panel of the timekeeper Barbara Meeks. Questions Kristen Day asked of the candidates included "What makes you the most qualified? What makes your platform unique? How has community involvement helped with your qualifications?" Candidates were also given an opportunity for closing arguments.
- Announcements:** Roxann Lewis announced that February 16th. is an event for Julie Pickren and February 19th, there would be a gathering for Dr. Robin Armstrong. Della Brown announced the Lincoln Reagan Event April 30th and asked for volunteers. Roxann Lewis also encouraged everyone to consider the March 15th Nuts and Bolts training hosted by The Greater Houston Council.


