# April 2024 Legislative Update

## [ELECTION INTEGRITY](#)

On, 03-14-24, a petition for writ of certiorari was filed with SCOTUS (**Docket No. 23-1021**) for the Arizona election integrity case filed in response to the 2022 midterm election by candidates for Governor and Secretary of State (SOS), Kari Lake and Mark Finchem, against AZ's SOS, Adrian Fontes, and the boards of supervisors of Maricopa and Pima Counties. The case challenges, "... **whether electronic voting machines assure a fair and accurate vote under the Due Process Clause ...**" of the Fourteenth Amendment of the United States Constitution. The testimony and evidence showed actual electronic vote tampering in prior elections, which the district court disregarded in finding petitioners' claims, "... **too speculative for Article III standing**" and whose finding and dismissal was subsequently upheld by the U. S. Court of Appeals for the Ninth Circuit. Lake and Finchem are asking SCOTUS to rule that they do have standing.

Before 2002, elections overwhelmingly were conducted using reliable auditable paper-based systems. **After the 2000 presidential election recount in Florida and the Bush v. Gore decision**, Congress passed the **Help America Vote Act (HAVA)**. Billions of federal dollars were spent to move states from paper-based voting systems to electronic computer-based systems. Since then, U.S. elections have mostly been conducted using computer-based **election management systems (EMS)** created, maintained, and administered with little to no public transparency by essentially 3 companies, **Dominion, ES&S (vendor in many TX counties) and Hart InterCivic (vendor for Galveston, Harris and other TX Counties)**.

Prior to the 2016 federal election, a series of cyberattacks occurred on state and local election information systems. Consequently, the Department of Homeland Security (DHS) in January **2017 designated the election infrastructure used in federal elections as a component of U.S. critical infrastructure (CI)**. Under federal law CI refers to systems and assets for which "incapacity or destruction ... would have a debilitating impact on security, national economic security, national public health or safety, or any combination" of them (42 U.S.C. §5195c (e)).

**As of 2019, Dominion, ES&S and Hart InterCivic supply more than 90% of the nation's EMS**. Computer science experts have demonstrated that all three companies systems can be hacked or compromised with malware. Since the 2020 general election evidence has been mounting that establishes illegal acts were carried out surrounding the 2020-general and 2022-midterm elections. These acts permeated the election infrastructure and processes across the country. **Following the 2020 Mesa County, CO general election a series of events occurred that would provide a unique glimpse into the actual Dominion EMS**. Voters in Mesa County, concerned that their votes had been somehow compromised, expressed their concerns to Tina Peters, a Navy SEAL Goldstar Mom and the elected Mesa County Clerk. On, 05-25-21, CO's SOS authorized Dominion to perform a new trusted software build that would replace the build used for the 2020 election, would be prior to and therefore in violation of the legally mandated elections records preservation statute requirements (22 months-U.S./ 25 months-CO) and would make it impossible to verify the results of the 2020 and 2021 elections. Concerned about this and wanting to fulfill her legal responsibilities Tina Peters engaged a consultant to make a forensic backup of the 2020 election Dominion EMS server prior to implementation of the new trusted software build. This **provided the first opportunity for forensics experts to analyze the internal workings of the Dominion EMS and compare the 2020 election and new trusted build internal databases; the results of which provided the necessary evidence to file this AZ election integrity lawsuit**. The state of CO indicted Tina Peters on criminal charges for tampering with election equipment; her home was searched by the FBI and her computers, phones, etc. were confiscated. She is currently under threat of being sent to prison. For her story and the forensic audit reports see:

Per SCOTUS case Docket No. 23-1021:

"... Decades of Evidence Prove Electronic Voting Systems Do Not Provide a Secure, Transparent, or Reliable Vote

71. Over the last two decades the United States has transitioned from a safe, secure, auditable paper-based system to an inherently vulnerable, network exposed electronic equipment-based system. The transition to increased reliance on electronic systems and computer technology has created unjustified new risks of hacking, election tampering, and electronic voting fraud.

72. With each passing election the unreliability of electronic voting machines has become more apparent. In light of this experience, the vote tallies reported by electronic voting machines cannot, without objective evaluation, be trusted to accurately show which candidates actually received the most votes.

73. Credible allegations of electronic voting machine "glitches" that materially impacted specific races began to emerge in 2002. ...

## Legislative Update cont'd

Per SCOTUS case Docket No. 23-1021 cont'd:

125. Evidence has been found of illegal vote manipulation on electronic voting machines during the 2020 election.

126. Dominion Democracy Suite software was used to tabulate votes in 62 Colorado counties, including Mesa County, during the 2020 election. Subsequent examination of equipment from Mesa County showed the Democracy Suite software created unauthorized databases on the hard drive of the election management system servers. On March 21, 2022, electronic database expert Jeffrey O'Donnell and computer science expert Dr. Walter Daugherty (*TX A & M professor emeritus*) published a report concluding that ballots were manipulated in the unauthorized databases on the Mesa County server during Colorado's November 2020 and April 2021 elections. 127. On February 28, 2022, and after a comprehensive review of the Dominion systems used in Colorado, cybersecurity expert Douglas Gould published a report concluding that the system was "configured to automatically overwrite log files that exceed 20 MB, thereby violating federal standards that require the preservation of log files," that it was configured "to allow any IP address in the world to access the SQL service port, (1433), which violates 2002 VSS security standards," and that it "uses generic user IDs and passwords and a common shared password, some of which have administrative access," in violation of 2002 VSS security standards.

128. Retired Wisconsin Supreme Court Justice Michael Gableman conducted an investigation of the 2020 election in Wisconsin at the direction of the Wisconsin Assembly. Gableman issued a report in March 2022 noting that "at least some machines had access to the internet on election night." He concluded that several machines manufactured by ES&S and used in the 2020 election in Wisconsin were "made with a 4G wireless modem installed, enabling them to connect to the internet through a Wi-Fi hotspot."

In addition to the forensic audit conducted on the Mesa County Election databases, [O'Donnell and Daugherty conducted an analysis of cast vote records \(CVR's\) for numerous counties in the United States](#), including AZ's Pima and Maricopa Counties. The CVR's were mostly acquired by citizens via FOIA requests to their county election clerks. The CVR collects in spreadsheet format the selections contained on each ballot in the order recorded through the tabulator machines without any information that would identify the voter (i.e., no name, address, Social Security number, driver's license number, voter registration number, etc.). See: [magaraccoon.com](https://magaraccoon.com), [fingerprintsoffraud.com](https://fingerprintsoffraud.com) for "[Fingerprints of Fraud](#)" [2020 Election Cast Vote Record Report, Volume 1](#) which provides findings taken from the 2020 General Election Cast Vote Records (CVR) of 202 counties from nine states, Arizona, California, Colorado, Idaho, Nevada, New Jersey, Ohio, Oregon and West Virginia. Volumes 2 and 3 for other states are in work.

Cited in case Docket No. 23-1021, from his statement in the AZ case, Dr. Daugherty states, "... in the November 2020 election for which the CVR data was made available, ballots in Maricopa County and Pima County were artificially processed through the tabulators tracking a Proportional-Integral-Derivative (PID) type control function in a closed-loop feedback system. A PID controller or variations of it is a software coded algorithm to maintain a measured process variable (that is, an outcome, such as a ratio) at a pre-specified desired setpoint ...

8. PID controllers are used everywhere, from cruise control in automobiles to Category III autoland for an aircraft making a landing when the runway is completely fogged in, to industrial automation of all kinds, such as robots, refineries and other chemical plants, manufacturing quality control, and self-driving cars.

9. An analysis of the actual cumulative ratios of the vote tallies for early mail-in and in-person votes prior to Election Day ("early votes") for the ten races analyzed in Maricopa County and the seventeen races in Pima County shows a significant and systematic decline in the cumulative ratio as counting progresses. Such a uniform and predictable pattern is so statistically implausible that it would not occur without artificial manipulation. ...

11. As detailed below, my analysis shows to a reasonable degree of scientific and mathematical certainty that vote counting by electronic voting machines used in Maricopa County, Pima County, and other counties throughout the United States that I have examined was manipulated and tightly controlled to reach predetermined outcomes. ... In my expert opinion such predictability is so statistically improbable as to be impossible without manipulation or control and thus demonstrates to a reasonable degree of scientific and mathematical certainty that the tabulation of these ballots was artificially controlled. ... 33. Note that neither the current Arizona statutory election audit procedures nor the various forms of risk-limiting audits used by other states would have detected this controlled manipulation, since they do not take into account the sequence that votes are recorded. ...

42. The evidence detailed above overwhelmingly demonstrates to a reasonable degree of scientific and mathematical certainty that the sequence of the CVR data in both Maricopa County and Pima County shows artificial control. ...

45. Unless and until future proposed electronic voting systems (including hardware, software, source code, firmware, etc.) are made completely open to the public and also subjected to scientific analysis by independent and objective experts to determine that they are secure from manipulation or intrusion, in my professional opinion as a computer expert, electronic voting systems should not even be considered for use in any future elections, as they cannot be relied upon to generate secure and transparent election results free from the very real possibility of unauthorized manipulation. My professional opinion as a computer expert is therefore that hand-marked hand-counted paper ballots should be used instead.

46. I have personal knowledge of the foregoing and am fully competent to testify to it at trial. I declare under penalty of perjury that the foregoing is true and correct. Executed on June 8, 2022 Walter C. Daugherty."

Additionally, recent new evidence has been provided to SCOTUS in case Docket No. 23-1021 showing that, "... since at least 2020, Dominion configured its machines with the decryption keys in an election database table in plain text—protected by nothing other than Windows log-in credentials that are easily bypassed— enabling any malicious actor total control over its electronic voting systems. ...

195. ... Accordingly, Plaintiffs ask this Court to declare that these Defendants violated the Due Process Clause of the Fourteenth Amendment of the United States Constitution and Article 2, Section 4 of the Arizona Constitution; enjoin Defendants' use of electronic voting systems for future elections..."

# April 2024 Legislative Update cont'd

## BORDER CRISIS

03-21-24, In El Paso on the border TX National Guard troops were rushed and overrun by illegal aliens who fought their way past to be processed by Border Patrol Agents. SB4 provides the ability for TX to legally enforce the capture and return of illegal aliens. However, **SB4 is currently on hold pending further review by the U.S. Fifth Circuit Court of Appeals.** Per the U.S. Constitution TX is arguing that it has the right and responsibility to defend its borders when the federal government has abrogated its responsibility to defend the states against invasion.

### COMMITTEES & CAUCUSES

*Senatorial District (SD) Caucus* – Twice during the convention, delegates will meet together with all the other delegates from their same State Senate district to hold a Senatorial District Caucus. The first SD caucus will be called to order by that SD's Temporary Caucus Chair. These Chairs were appointed by Chairman Rinaldi upon the recommendation of one or both of that district's SREC members. After the meeting is called to order, the delegates will elect a Permanent Caucus Chair to conduct the rest of the caucus business.

*Congressional District (CD) Caucus* – Twice during the convention, delegates will meet together with all other delegates from their Congressional district to hold a Congressional District Caucus. The first CD caucus will be called to order by the CD's Temporary Caucus Chair - who is appointed by Chairman Rinaldi. After the meeting is called to order, the delegates will elect a National Committee Woman, National Committee Man, National Delegate, Presidential Elector, and National Nominations Committee member.

*Temporary Committees* – Each of these committees includes 32 people: a chairman appointed by State Chairman Matt Rinaldi, and one member from each of the 31 Senatorial Districts (SDs) appointed by Chairman Rinaldi upon the recommendation of one or both of that district's SREC members.

# Campaign Activities

## Reporting Hours

**You can report hours monthly (click here):**

Look at your calendars/phones at all of your hours. If you have not started reporting your volunteer hours this year, now is the time to start. With the new changes, we may now include hours worked as election clerks, election judges, making phone calls and time spent working for candidates as long as you are not employed by them. Don't forget your travel time to and from events, and any preparations for those meetings or events. Our Galveston County GOP Headquarters has been open and will be reopening again soon just a few offices down. Please **don't forget to volunteer and keep a record of your hours spent**. Awards will be given by TFRW and NFRW to members and clubs volunteering **and reporting** the most hours.

As a reminder...New Categories for Reporting Hours and what to include:

1. **CALLING**

Include all calls for any political activities, such as initiatives or ballot questions.  
Dialing apps will record the number of calls you have made, or you can use your best estimate.

2. **POLITICAL HOURS**

When in doubt, count the hour and round up to the closest whole hour.  
Travel time to and from the activity.  
Research and development of the activity (Example: Social media posts / letters to the editor).  
Preparation and breakdown of activity hours collected are on a best estimate basis.

3. **PRIMARY and ASSOCIATE MEMBERS** hours are counted.

All volunteer political activities, whether paid or unpaid (Example: paid election worker or poll watcher), are eligible.  
\*Individuals who are salaried campaign and/or GOP professional staff do not qualify (i.e., those who earn their living by being employed in politics).

**EXAMPLES OF ACTIVITIES**

- ◆ All time spent at Club, Region, State, and National Federation meetings or conventions (in person or virtual).
- ◆ All campaign activities benefiting the Federation (TFRW), the Republican Party, or Republican candidates.
- ◆ Attendance at all Republican events, including Rallies, Lincoln Day Dinners, even if tickets were purchased for attendance.
- ◆ Running for Office (partisan or non-partisan) as a Republican Candidate.
- ◆ Walking precincts, preparing letters to the editor or elected officials, any phone calls, radio, TV and social media appearances, posting to social media, voter registration, writing or editing a digital or hardcopy club newsletter, attendance at rallies.
- ◆ Working on any aspect of a Republican campaign (partisan or non-partisan) .
- ◆ Working on Republican ballot questions, initiatives, or petitions.
- ◆ Time spent serving as an elected member of your Local, County, State or National Party Committee.
- ◆ Attending, preparing for, or volunteering at Club, Region, State, and National Federation meetings or conventions.
- ◆ Attending, preparing for, or volunteering at meetings or conventions of the Local, County, State, and National Republican Party or local meetings or conventions.
- ◆ Working at a Local, County, State, National Republican office.
- ◆ Working at a Local, County, State, National Republican candidate or elected official's office as a volunteer.
- ◆ Working as an Election Officer, Poll Watcher, Challenger, or Election Integrity worker.
- ◆ All campaign activities benefiting our Republican Party, candidates, and/or the Federation (TFRW).
- ◆ Time spent making political and campaign calls.
- ◆ Any other political or campaign activities.



## 2022 Texas GOP Priorities

These priorities were chosen by over 5,000 voting delegates at the state convention, June 13-18, 2022 in Houston, Texas. Delegates were presented with a [list of 15 topics selected by the Legislative Priorities Committee](#) after a comprehensive review of resolutions passed at the precinct and senate district levels of the convention process. Delegates were allowed to vote on 8 topics, which became the official Legislative Priorities of the Republican Party of Texas.

### 1. Protect our Elections:

Restore felony penalties and enact civil penalties for Election Code violations, which shall be enforceable by any Texas jurisdiction, including the Texas Attorney General. Require citizenship verification of each voter. Restrict the distribution of mail-in ballots to only disabled, military, and citizens that are out of state. Reduce the time allowed for early voting, and eliminate the three-day gap between early voting and election day. Establish closed primaries in Texas. As technology evolves, we encourage the passage of legislation that ensures the security of our elections.

### 2. Secure the Border and Protect Texans:

Texas shall immediately deny all taxpayer funded services and subsidies to illegal aliens. We call upon the Governor to assert his duty under Article 1, Section 10, Clause 3 of the US Constitution to declare an invasion on our Texas border and do everything in his power to protect Texans from this invasion. The legislature shall direct the Governor to enter into an Interstate Compact with one or more states for Border Security.

### 3. Ban Gender Modification of Children:

Texas must ban chemical castration, puberty blockers, cross-sex hormones, genital mutilation, bodily alteration surgery, psychological/social transitioning, and any other methods applied to or performed on children.

### 4. Stop Sexualizing Texas Kids:

Repeal Texas Penal Code "Obscenity Exemption" 43.24(c), which allows children access to harmful, explicit, or pornographic materials and 43.25(f)(2 3), which allows sexual performance by a child. In addition, prohibit teaching, exposure, and/or discussion of sexual matters (mechanics, feelings, orientation, or "gender identity" issues), and prohibit use or provision of related books and other materials using criminal, civil or other enforcement measures.

### 5. Ban Democrat Chairs:

To ensure all legislative Republican priorities are given a fair opportunity to become law, the Republican-controlled Texas legislature shall adopt a rule that would end the practice of awarding committee chairmanships to Democrats.

### 6. Abolish Abortion in Texas:

Abolish abortion by ensuring the right to life and equal protection of the laws to all preborn children from the moment of fertilization, including adopting effective tools to ensure the enforcement of our laws to protect life when district attorneys fail to do so.

### 7. Defend Our Gun Rights:

Protect our gun rights against threats, such as red flag laws, federal, state or other restrictions, by strengthening and preserving our inalienable rights under the second amendment to protect our life, liberty and property. The Texas Legislature should eliminate gun-free zones.

### 8. Parental Rights and Educational Freedom:

Parents are the primary decision makers for their children in all matters. This authority shall be protected as an inalienable right. This shall include the choice of schooling where the money follows the child without strings attached, and enforcement and penalty mechanisms when parents' rights are violated. The right to education shall be free from any social theories.
