## Campaign Activities Volunteer Hours Reporting

We have already come to the end of the first quarter and your volunteer hours need to be included in the submission! Coming off a Primary Election, I know that many of you spent countless hours helping your favorite candidate. Please go online to [clearcreekrw.org](http://clearcreekrw.org) as outlined in last month's newsletter and let me know how many hours you accumulated. To our many male Associate Members who claim CCRW as their main club, we would like your hours as well! If you were a candidate and submit your hours, you just might be our winner of the month! I know how hard you worked every single day.

This month, I am including a helpful list of what you may **not** count. Travel to and from any of these positions counts as does any preparation before and after.

### What does NOT count as Campaign Activities/Political Action hours?

1. If you are a paid employee for a candidate or elected official, any political activity done under your official capacity, where you are compensated financially, does not count.
2. Any other paid political activity, such as serving as an Election Judge, Signature Verification or Central Count or related work.
3. Time spent at a club's monthly meeting does not count but travel to and from does.
4. Money donated to campaigns or to Republican organizations cannot be counted. We can only count volunteer time.

Community service hours that are not political in nature should be reported to the TFRW Caring for America Chairman. After reviewing the election results across the state, it is revealing to notice that it is not how much time or money that was spent but it is ultimately getting your voters to the polls. A primer for the Genral Election should reflect this and recognize that the GOTV is most important!
