#### Book Review:



#### The Greatest Speeches of Ronald Reagan

Who said, "I have wondered at times about what the Ten Commandments would have looked like if Moses had run them through the U.S. Congress and the taxpayer: That's someone who works for the federal government but doesn't have to take the civil service examination."? If you guessed 40<sup>th</sup> President, Ronald Wilson Reagan, you are right! The book, "Greatest Speeches of Ronald Regan", compiles the wisdom, wit, and warmth of one of our greatest Presidents.

Reagan was a visionary on par with our Founding Fathers. He had the charm of Kennedy and Clinton, without the moral failings. He was a student of history. He was a man of great faith in God (did you know the "Evil Empire" speech was to the National Association of Evangelicals in 1983?). Most of all, he was an optimist, as evidenced by his "New Republican Party Speech containing the reference to "a city upon a hill" (pg. 49-67) [note there is also a speech titled City Upon the Hill" (p. 19)].

Reagan was certainly a great speechwriter. Not to take away from Peggy Noonan and the other wonderful speechwriters he employed, but many of his greatest speeches were written in his own hand. We are fortunate to have this compilation of some of his finest words.

The book opens with a speech given as part of Barry Goldwater's Presidential campaign and continues, chronologically, to his Last Letter to America (which still makes me cry). My favorites are the 1986 State of the Union Address (day of the Challenger disaster), his first Presidential Nomination Acceptance speech ("Is the United States stronger and more respected now than it was three and a half years ago?"), and of course, "Mr. Gorbachev, Tear Down This Wall".

Reagan was a great national cheerleader. He often pointed to the accomplishments of our country as evidence that ours was not a "sick society". He realized that, "All we need to do is take action, and the time for action is now." His firm belief in tax relief comes across loud a clear, as applicable today as it was at the time of his speeches. This book provides a wealth of history (Solidarity in Poland, the Cold War, space). I am privileged to have lived in California while Reagan was governor (his second campaign was the beginning of my interest in politics) and through his presidency in the 1980's.

The book has a timeless quality, "That message (of the previous November's election) was very simple: Our government is too big, and it spends too much" (from a speech in 1981) and "we must enforce the dictates of our (UN) Charter and resume the struggle for peace". It is available from Newsmax (<a href="https://www.newsmax.com">www.newsmax.com</a>).

The only thing in my opinion that would make the book better

would be an index, so that favorite quotes could be quickly referenced. This is not a book to be read in one sitting book. It is a great coffee table book (quite the conversation starter!).

"I never thought it was my style or the words I used that made a difference. It was the content." (from his farewell address).
