#### February 3rd Mínutes



The regular meeting of the Clear Creek Republican Women was called to order at 12 noon by President

#### Víctím Reductíon Courts



Guest Editorial: Judge Robert W. Francis, Criminal District Court #3, Dallas President, "Texas Association of Drug Court Professionals"

Texans, like all Americans want to reduce crime and thereby reduce the numbers of innocent victims. In this effort we have instituted programs and slogans such as "Zero Tolerance" and "Tough On Crime", yet our crime rates continue to increase. The public has demanded that the legislature and courts come up with a solution. The result has been the development of "Drug Treatment Courts".

Drug treatment courts are designed to work with non-violent offenders to transform their behavior so that they comply with the rules that the rest of us follow. Graduates of these courts are drug free, employed, responsible citizens who pay taxes instead of using up valuable tax dollars. The best result of course, is a reduction of the number of Texans who would otherwise be crime victims.

Texas has approximately fifty different drug treatment courts in operation at this time. Whether they are pre-indictment, post-indictment, diversionary or post-conviction they all operate on the same basic premise. Change peoples behavior through a graduated system of incentives and sanctions, and you can improve the lives of all Texans at a minimal cost.

Studies done at local, state and national levels all validate the success of these courts in reducing crime substantially. The average cost of imprisoning an offender is around \$28.00 a day, court programs cost around \$2.50 a day. Not only do these courts reduce crime, they save tax dollars and open prison beds so that violent offenders serve longer sentences, thus serving to protect us and our children.

From Governor Rick Perry all the way down to your local courthouse, elected officials have endorsed this type of innovation as being highly successful and conservative.

Next time you are at your courthouse, stop by and observe the "Drug Treatment Court" in your own jurisdiction and see crime reduction in action. As Texans we must continue to be "Smart On Crime" and "Make Our Communities Safer".

# Legíslatíve Update



**AUSTIN** - Lt. Governor David Dewhurst recently named State Senator Mike Jackson (R - La Porte) Chairman of the Senate Nominations Committee. The Committee is responsible for confirming the Governor's appointees to positions at approximately 400 boards, commissions and agencies in Texas. Committee members interview appointees at public hearings throughout the legislative session and then vote on whether or not to recommend each appointee to the full senate for confirmation. As chairman, Senator Jackson will schedule hearings, meet with appointees and their respective staff and direct the committee through the confirmation process.

**AUSTIN** - Gov. Rick Perry launched "Operation Rio Grande," a state-led initiative to address escalating violence, increase border security and ensure Texans' safety. The operation brings together a variety of state resources to better secure the Texas-Mexico border from Brownsville to El Paso.

**WASHINGTON DC** - Sen. Kay Bailey Hutchison (R-TX), Vice Chair of the Senate Republican Conference, introduced a motion to instruct conferees for the Tax Reconciliation Act to make the state sales tax deduction permanent. This passed by a vote of 75-25 and gives guidance to the conferees as they develop the final version of the tax bill.

**WASHINGTON DC** - Sen. John Cornyn (R-Texas), chairman of the Immigration, Border Security, and Citizenship subcommittee, urged the Department of Homeland Security (DHS) on February 7 to speed implementation of the recently announced border-crossing cards for U.S. citizens. In a letter to DHS Secretary Michael Chertoff, Cornyn said, "increased security at our borders must be combined with policies that facilitate legal travel." Cornyn also reiterated his request for DHS to extend the laser visa period to six months for legal Mexican visitors, giving them full parity with Canadians.

Cornyn, the Border Texan of the Year for 2005, applauded DHS and the State Department for announcing in January a secure, less-expensive passport card for use by U.S. citizens in border communities, and also asked for an application-fee waiver for low-income Americans.
