She and her husband, Gary Mossman, are elders in their church and are involved in many civic organizations. They have three grown children, all graduates of Clear Creek ISD.

### Legíslatíve Update

**AUSTIN - HOUSE BILL 312.** Sponsored by Rep. Sylvester Turner of Houston, will give assistance to Texans needing help paying their electric bills. The bill forbids the use of credit history or credit scores in the denial or pricing of electric service for all contracts of one year or less.



AUSTIN – HOUSE BILL 2032. Sponsored by Rep. Harvey Hilderbran, will help state game wardens investigate crimes by offering a reward for information leading to an arrest and conviction through the Operation Game Thief program. The bill also allows Operation Game Thief funds to be used for technological advancements, to assist in the capture and prosecution of state law violators.

AUSTIN – SENATE BILL 6 reforms Family Protective Services. The dramatic, system-wide changes in protective services programs will strengthen investigations, support quality casework, improve the effectiveness of ongoing services, increase private sector involvement, build community partnerships, improve management and accountability and support families' rights.

AUSTIN – SENATE BILL 15. The Texas Senate passed strong legislation to control asbestos and silica lawsuit abuse in Texas. "The determination of Lt. Governor David Dewhurst, Senate author, Kyle Janek and the work of State Affairs Committee Chairman, Robert Duncan, won the vote of every Senator on the floor of the Texas Senate yesterday," said Texans for Lawsuit Reform founder Richard Weekley.

**WASHINGTON** – House Bill 424, sponsored by Congressman Ron Paul, would repeal the inclusion of Social Security benefits in gross income for tax purposes. Please write, email or telephone your representatives to say that you support this bill.

**WASHINGTON** –**ENERGY POLICY ACT of 2005** Passed the House by a vote of 249-183, which included the support of 41 Democrats. The energy plan enhances conservation, research, and development and provides for security and diversity in the energy supply for the American people.
