#### **Deputy Ceremony**

"To encourage voter registration, the registrar shall appoint as deputy registrars persons who volunteer to serve..." Texas Section Code, Section 13.031.

In the past, members of Republican women clubs in the area carpooled to Galveston Island joined their southern friends for lunch at Gaido's and journeyed to the Galveston County Courthouse Tax Office to be deputized as volunteer deputy voter registrars. Although we love having Republican Women hang around the office, Allison Kearney, Voter Registration Coordinator for the Galveston County Tax Office, and I are thrilled to be coming to see you!

The Tax Office set an aggressive goal this fiscal year to increase the number of registered voters by 5%. That means we have eight (8) months to register approximately 8,943 qualified voters. It is our sincere hope that, after a very short presentation of the duties and responsibilities associated with being a deputy, you will join us in working to achieve this goal. We will perform a brief swearing in ceremony at the meeting.

Voting is one of the most important acts of citizenship available to Americans today and likely the least exercised activity among our citizens. You know the importance of one vote and understand the importance of being involved in electing responsible people to public office. Government is better when people participate. And, in the words of our own Secretary of State Roger Williams, "We don't have time to be involved and become informed but we don't have time either NOT to."

#### Did you know

Ö Texas was the first state to vote from space?

Ö 72% of eligible women and 64% of eligible men are registered to vote?

Ö Texas ranked 43rd in the Nation for percent of women 18+ registered to vote and 49th in the Nation for percentage of women who actually voted?

If you have not already voted, as one of the 72%, I urge you to take one of the 64% and vote November 8th.

## Legíslatíve Update



#### From the State of Texas

The Texas Election Code under went significant revision and will effect this year's election. Most of these new election laws became effective September 1, 2005. To highlight a few of the reforms, the Code now:

• Adds tampering with a direct recording electronic voting machine to the Texas Penal Code: the offense is a 1<sup>st</sup> degree felony, but becomes a 3<sup>rd</sup> degree felony for an attempt to commit the offense

• Eliminates February and September uniform election dates and moves the May uniform election date to the second Saturday in May.

• Changes also occurred in the maximum number of precinct voters, it was 3,000 and is now 5,000

This was just a couple to mention. You may read more about it by looking up <u>www.house.state.tx.us</u>, than look under the bill which is #2759.

**NOTE:** On November 8, 2005, remember to VOTE FOR PROP# 2, stating that marriage is between a man and a woman. Please protect this sacred right.

#### **U.S. House of Representatives**

As you all are aware of U.S. House Representative Tom DeLay has been indicted and we have to show our support for him. Attached is the latest article where Governor Rick Perry is showing his support. #### From the Associated Press:

``I'm for Tom DeLay. I don't get confused about what's going on here," Perry, a fellow Republican, said after speaking about economic development at the Fort Worth Chamber of Commerce. ``The fact of the matter is I happen to think that this is an overzealous prosecutor who is working very hard to take a Texan off of the national stage who's been doing some great and good things for the state of Texas." When Perry said he believed DeLay should remain the House majority leader, the crowd of about 450 people erupted in applause. The felony charges forced DeLay to give up his leadership post, but he wants his job back.
