#### From Our County Treasurer By Kevin Walsh, CPA

#### A little over three years ago the citizens of Galveston County elected me Galveston County Treasurer. During my tenure, I negotiated a new three year bank contract; implemented an advanced check writing system; improved payroll processing, including direct deposit of checks; invested bond proceeds to help defray the high costs of construction; and have always under spent our approved budget. My office was over staffed, so I eliminated two of seven full time positions. At the same time, I made sure that the remaining employees were properly compensated for their hard work with less overtime waste.

You may ask, "What does the County Treasurer do?" The County Treasurer is the county's banker and chief custodian of County finance. We receive all monies that belong to the County; we keep and account for all monies in a designated depository; and make payments as directed by Commissioners Court, by law.

I am the chief liaison between the County and all depository banks. We maintain records of all deposits and withdrawals and reconcile all bank statements, to ensure accuracy and the safety of County funds. I am the County's investment officer and is required to submit regular reports on County finance to commissioner's court to inspect and verify.

The County Treasurer is elected at each general election in which the office of governor is to be filled for a full term, and must successfully complete at least 20 hours of continuing education in each 12-month period.

Today, the Galveston County Treasurer's office is stronger and more unified than ever before. Relationships among County officials have been mended; employees have returned to work; lawsuits over which I had control were either dismissed within six months, or rulings by the judges in favor of the County were handed down. Vendor payments are being timely processed and bank accounts are now properly utilized to maximize interest earnings.

Thank you for allowing me to serve you. I appreciate your faith, your support and your vote in 2002. I hope you will allow me to continue the good work my staff and I have done for Galveston County.

# Legíslatíve Update

AUSTIN- Lieutenant Governor David Dewhurst and Speaker Tom Craddick released the names of Senate and<br/>House of Representatives appointees to the Joint Select Committee on Windstorm Coverage. The committee, is<br/>charged with addressing what insurers and lawmakers say is a potential crisis for the Texas Windstorm Insurance<br/>Association.



The Joint Select Committee is composed of six senators appointed by the Lieutenant Governor and six House members appointed by the Speaker of the House of Representatives. **Sen. Mike Jackson (La Porte)** and Rep. John Smithee (Amarillo) will co-chair the Committee. Senate appointees include Sen. Robert Duncan (Lubbock), Sen. Troy Fraser (Horseshoe Bay), **Sen. Kyle Janek (Houston)**, Sen. Eddie Lucio, Jr. (Brownsville), and Sen. Royce West (Dallas).

House of Representatives appointees include Rep. Warren Chisum (Pampa), Rep. Joe Driver (Garland), Rep. Allan Ritter (Nederland), Rep. Gene Seaman (Corpus Christi) and **Rep. Larry Taylor (Friendswood).** 

WASHINGTON DC - U.S. Sen. John Cornyn, Chairman of the Immigration and Border Security subcommittee, made the following statement regarding his vote against final passage of a committee bill that included amnesty for millions of illegal immigrants:

"I voted against this committee bill because it rewards illegal immigrants and will be considered an amnesty by Americans. It will encourage further disrespect for our laws, and will undercut our efforts to shore up homeland security. There is a better way to address this national security concern, and several of those who voted for the committee bill—including the chairman—did so with reservations."

"Adding border security measures to the McCain-Kennedy bill is not enough. But now that the full Senate debate is underway I'll work for a comprehensive solution to our immigration situation, one with additional border security, interior enforcement, and employer accountability. And while we must address the12 million illegal aliens already here, we have to do so without granting them amnesty." *Kathíe Nennínger*
