
Campaign Headquarter News

Legíslatíve Update

AUSTIN - Speaker Tom Craddick announced the appointment of Dan Flynn and Ike Sugg to the Sunset Advisory Commission. The Sunset Advisory Commission is a 12-member body of legislators and public members appointed by the Lieutenant Governor and the Speaker of the Texas House of Representatives. The Commission then draws conclusions about the agencies under review based on the reports.

AUSTIN - Governor Rick Perry confirmed that Texas would reinstitute the state's Medicaid program to provide medicines for those who cannot enroll in the federal plan. Texas will join 25 other states in offering some coverage to patients who cannot access the new federal program. While the cost to the state for this could be considerable, Washington says it will reimburse the state for expenditures up to February 15.

WASHINGTON - U.S. Sen. John Cornyn, a member of the Senate Judiciary Committee and former Texas Supreme Court justice, made the following statement after the committee vote on the nomination of Judge Samuel Alito to serve as Associate Justice of the U.S. Supreme Court. The vote was 10-8 in favor of confirmation: 'We as a Committee will need to come to terms with our confirmation process which too often treats Supreme Court nominees more like piñatas than human beings', said Senator John Cornyn following the recent confirmation of Sam Alito.
