# Legislation Watch

Since Congress has been in recess, there is little to report. The following may be of interest:

Thursday, January 22nd, was the 31st Anniversary of the landmark Supreme Court decision that made abortion legal in this country. Since the Roe vs. Wade decision, over 40 million babies have died. This is a tragedy that can be stopped with diligence and determination. Let us continue that process by pressing our Legislators to stop abortion.

### The Senate

The Senate returned on January 20th to face rising opposition to the Omnibus spending bill. The Omnibus bill is needed because Congress failed to pass 7 of the 13 spending bills needed to operate the government. When these seven were all combined together into the Omnibus bill, a tremendous amount of fat was included to win votes from various Senators and Congressmen. The bill is huge and contains such things as \$2 million for a golf program in St. Augustine, Florida to provide access for golf to everyone including kids; \$1.8 for a fruit laboratory in West Virginia; and money for a Rock and Roll Hall of Fame, just to name a few. If this bill passes there will be an election year shift, with Democrats pointing to a "big government" Republican president backed by a "big spending" Republican Congress. Before this is passed some budget knives need to be taken to it. There are better uses for your tax dollars and mine.

# Campaigns

### 2004 Campaign Activities

Keep track of those campaign hours! CCRW is required to report club hours to TFRW quarterly. The total hours accumulated by TFRW Clubs every two years help to quantify our volunteerism to NFRW, elected officials, and the Republican Party of Texas. And then of course, there is the thrill of winning a TFRW Campaign Activities Club Award! Don't underestimate your hours, included below is a list of reportable activities.

- Only count hours pertaining to non-paid political activities. Hours as Election Judge, Clerk, Poll Watcher count ONLY if pay is turned over to a county party, your local Federated Republican Women's Club, a candidate, or the TFRW PAC.
- 2. Include work done at home such as mailings, preparing campaign posters or signs, telephoning solicited by a candidate campaign, baking for a campaign, but not for club meetings.
- 3. Count hours spent working at a special event or organizing the event but NOT if you attend as a guest or if you are compensated for the event.
- 4. Count hours spent in session at Federation Board of Directors meetings and Federal Conventions also time spent in preparation of convention if on committee. You may include travel time.
- 5. Count hours spent in session at precinct, county/district or state party conventions. You may include travel time. NOTE: Please remember to attend your precinct convention.
- 6. You may count hours spent as members of county or state party committees—ONLY during scheduled meeting times. You may include travel time.
- 7. Count political work done at club meetings, i.e. driving a candidate, working on mailings, getting candidate petitions signed, etc. DO NOT count hours in regular meetings.
- 8. Volunteer hours done at county, state, or Federal headquarters may be counted BUT NOT for paid staff positions.
- All hours volunteered at campaigns and at headquarters include portal to portal travel BUT NOT stops for personal errands.

- 10. County nonpartisan hours for known Republican candidates in city or school board elections.
- 11. Women candidates who are members of a club may count their campaigning as volunteer hours as long as no salary is accepted. A separate award will be given in this category at award events.
- 12. Male associate members may count volunteer hours and must follow the same rules which apply to regular members. Male candidates cannot count hours working on their campaigns.
- 13. A dual member's hours are only counted in her primary club.
- 14. Whenever possible, please have your hours verified and initialed by the campaign or headquarters. This will help determine where our hours are most utilized.
- 15. NOTE: Presidents and Campaign Activities Chairs are not permitted to work in nonpartisan as well as campaigns when there is more than one Republican in the race. Clubs may not endorse in the name of the club. Individual members may work for the Republican of their choice.

# Voter Registration

### **Voter Registrars**

I encourage everyone to be "deputized" voter registrars. To be deputized, go to the Tax Assessor/Collector's Office in the County Courthouse in Galveston (not an Annex) and complete a form. Upon completion, you will receive a packet with instructions and forms (and we can use all the forms we can get!). VOTER REGISTRARS MUST RECERTIFY ANNUALLY! Let me know when you are deputized! Should anyone want to organ-

ize a 'road trip' to Galveston, be deputized, and have lunch, please contact me.

### **Voter Registration Locations**

Suggestions would be appreciated for locations to register voters. Non-deputized people may assist deputies at booth locations, although they may not handle the forms. Ideally, two people should be on hand at all locations. When considering booth locations, think about attendance, for example, churches or schools during festivals, etc. Neither CCRW nor candidates may advertise at the booth and only Galveston County residents may be registered (forms may be provided to other county residents). Send suggestions to me at krogers@ghg.net. Please provide contact information as well as location ideas. Card tables, chairs, and (if in the sun) a canopy would be nice although not necessary.

### **Help Register Voters!**

Non-deputized volunteers are needed to assist with voter registration at Friendswood High School during lunches during late January. Remember—voters must be registered **before February 6**<sup>th</sup> to vote in the primary election. Voters must be 18 years of age by March 2 in order to vote in the primary.
