Legislation Watch

FEDERAL

The following message came recently from the American Family Association Online, Founded by Donald Wildmon. We've discussed this topic before, but the twists and turns this has taken through Congress has been amazing. Now, as you will read below, our Senators are "taking the high road" in only referring to the Federal Marriage Amendment as a "defense of marriage" act, so as not to offend the homosexuals. How can one take a high road by doing a low thing? Can you believe that? It is my considered opinion that some of our Congress-critters need to be reminded that God made the first marriage with Adam and Eve...NOT Adam and Steve. Voter Registration

CCRW's recent Voter Registration resulted in 9 new registered voters (3 in Galveston County and 6 in Harris County). We also distributed 15 forms (plus one since then) to interested voters. Mary Burney and Kathy Rogers (along with Kathy's daughter, Julie) staffed the booth at the Friendswood Kroger on 2351 and 518 on Saturday April 10 from 11-2. Many thanks to Kroger management for their support; they also allowed us to leave forms in the break room for employees.

Madonna Crame and Kathy will be at the Galveston County League City Annex Tuesday April 27 from 11-1. We know they have forms inside, but Commissioner Clark suggested that the taxpayers who visit at the beginning and end of each month aren't necessarily thinking about voter registration, so our presence there could get some of those taxpayers to vote! If we have success like our early April date at Kroger, we might want to consider being at that location other weekdays the first and last week of each month.

We will be registering voters in Santa Fe sometime this summer. Other locations we've got permission (but no dates set) are: League City Library, San Jac South, Randall's in League City, and Tommye Randolph's subdivision. If you live in an area where there are a lot of new voters (people who have recently moved in) let us know. We are also trying to figure out how to register voters at the Village Fair (the issue is that Galveston County will not allow us to reveal our party or candidate affiliation).

Election Worker Training - Schedule Alert

We need to make sure that election workers for all elections in Galveston County are as thoroughly trained and prepared as possible. Galveston County Clerk Mary Ann Daigle arranged for two training sessions (one held prior to publication). The (remaining) session will be conducted by a professional from "McKenzie Voter Training Service" and will address a wide array of election procedures including Posting Notice Changes, Qualifying Voters, New Provisional Voting Procedures, Pollwatchers, First Time Voter Procedures, SETTING UP and CLOSING a polling location, and delivery of voted materials.

I want to make sure that as many as possible of the election workers around the county attend. Even if you are not sure that you are going to be an election worker this cycle, it is important to get the knowledge about proper elections procedures out there. You never know when a last minute change will cause you to be called on.

Book Review

Shut Up and Sing

Shut Up and Sing is an admonition by talk host and conservative writer, Laura Ingraham, to those in the entertainment industry to quit displaying their ignorance and their biases by speaking on political topics. Ingraham writes in the same irreverent, entertaining, and enlightening style that she uses on her morning talk show (KSEV 700 AM 9-11). She exposes the hypocrisy of left on such issues as tolerance where they lobby for all things deviant although they condemn anything patriotic or Christian. She also points out that the "limousine liberals" want us to give up our SUVs while they travel around town in motor homes! She documents her arguments, with complete footnotes at the end of the book. Her humor-infused work also exposes the liberal-leaning media for what they are, the mouthpiece of the Democratic Party. She identifies many of the failures of the UN and the folly of

entrusting our national security to that organization. Her point is that singers (or actors or entertainers of any type) are just that, entertainers, and those with little or no education should not be given a political platform by the mainstream media (in most cases, just to cover up the guilt about being so rich and working so little).
