### Clear Creek Republican Women April 3, 2009 Minutes

President, Barbara Meeks, called the May Clear Creek Republican Women's meeting to order at noon on April 3, 2009 at Esteban's Fiesta Shack in League City. Shirley Hendrickson led us in prayer followed by the Pledge of Allegiance led by League City Mayor Toni Randall and the Texas Pledge led by League City Council member Phyllis Sanborn.

Barbara introduced the elected officials and candidates. Barbara then read the names of our 17 guests attending.

Shirley Hendrickson introduced our speaker the Honorable League City Mayor, Toni Randall who gave a "State of the City" report.

The business meeting resumed.

The minutes of the March 6th meeting, published in the newsletter, were approved with no corrections.

PAC Treasurer, Roxann Lewis, gave the treasurer's report stating that we have an ending balance of \$3569.71. There were no additions or corrections and the report will stand for internal review.

#### Officer Reports

- V. P. Membership: Sarah Von Dran stated that we have 45 full members and 33 associate members. Sarah stated that "membership in an organization is a lifestyle".
- V.P. Programs: Shirley Hendrickson announced that next month would be a League City Candidates' forum. She will pass out 3 x 5 cards for members to submit their questions to the candidates as they sign in.

#### Committee Reports

- Campaign Activities Chairman: Rebecca Allcorn said that our members volunteered a total of 701 hours in March and a total of 1303 for the 1st quarter.
- •Legislation Chairman: Carole Ragland said that there would be a rally in Austin in support of the Voter Photo ID bill. She also discussed the Texas Sovereignty movement to reaffirm rights under the 10<sup>th</sup> amendment. Anything not spelled out in the Federal government should belong to the states. There are two pieces of legislation in committee: HCR 50 and HCR 66. She feels that they will not get out of committee. Information will be sent to those attending the TFRW Legislative Day. Our board suggested that we lobby on this issue.
- •Political Action: Roxann Lewis, Executive Director of the Galveston County Republican Party said that a group will be going to Austin on April 7<sup>th</sup> for the Voter Photo ID bill. The rally begins at 11:30am. Because of the 1969 Voters' Rights Act in Texas, voters can use other forms of ID. She asked if any election judges would write up their testimony to give examples of voter fraud. Ten copies will be needed. She said

that 70% of the people of Texas want to see this passed. Roxann also told of the 'Tea Party' that Congressman Olson is coordinating for the evening of April 14<sup>th</sup> in Friendswood at Centennial Park. More information will be emailed.

- Awards: Diane Gillette discussed the NFRW
  Caring for America Award and asked that
  those members who volunteer for different
  agencies helping people to send her the
  amount of time and money given plus a
  description of the activity. Diane also
  discussed the My Favorite Teacher Award
  and will be submitting the forms for our
  nominee, the Director/Curator of the West
  Bay Common Children's School and
  Museum, Catharin Lewis.
- Newsletter Editor: Carole Alexander said that she is still in the process of updating email addresses.

#### .Announcements:

- Barbara said that the League City Chamber would have a candidate forum on April 9<sup>th</sup> from 6-7:15pm for the League City Candidates for City Council. followed by a forum for the CCISD school board candidates.
- Barbara said that April 16<sup>th</sup> is TFRW's Legislative Day in Austin. She reminded everyone to wear red and showed the beautiful basket that Shirley Hendrickson had put together for CCRW.
- Kathy Rogers, President of Friendswood RW thanked Roxann Lewis and Barbara Meeks for their work on the Galveston County Lincoln Dinner. She also said that Friendswood RW will meet on April 23<sup>rd</sup> at Perry's Grill and the speaker will be Apostle Claver.
- Debbie Lindemann announced that Congressman Pete Olson would have the grand opening and ribbon cutting of his new office in Clear Lake on April 14<sup>th</sup> at 2:30pm. She also said that BARW would meet on May 22 at Bailey's American Grill at 11:30am. The speaker will be Railroad Commissioner Elizabeth Ames Jones.

- Carol Dean told of the 9/12 project meeting. She announced that talk show host, Glenn Beck, would be broadcasting his show at the April 15<sup>th</sup> Tea Party in front of the Alamo in San Antonio.
- Barbara thanked Bertha Adams and Lesley Bruemmer for being our Hospitality chairmen.
- Shirley Hendrickson told of a class at the Pearland Shooting Center located on FM 528 on Saturday.

The meeting was adjourned at 1:00pm.


