PRESIDENT'S MESSAGE

AMERICAN EXCEPTIONALISM

After four years of emphatically declaring America was not "exceptional", President Obama, in a speech last month, finally admitted that the United States was "exceptional". When I heard him say America was exceptional, I thought, "Wow, he must have had an epiphany moment." I agree one-hundred percent that America is exceptional. But then I began to wonder: What is American exceptionalism, and what makes America unique and different from other countries?



Are we exceptional because we have the greatest military in the world? Are we exceptional because of our geographical location? Are we exceptional because of our economical standing in the world? Are we exceptional because we don't overthrow our government by coups?

There are countries who don't think we are exceptional – "except" when they need help in defending their country against outside aggressors; "except" when they need help in pushing out terrorist aggression; "except" when they need help financially; "except" when there is a major natural disaster. And, yes, America has always been ready to give of her resources to those in need. America sends help and then leaves, leaving that country better than it was. In the course of history, we have left many of our finest men and women buried in other lands, and America asks nothing in return.

So what is it that makes America exceptional? I think it's an attitude and mindset that just "is" that has become embedded in the American psyche. I suppose one can say that American exceptionalism is a state of mind based on historical facts. As Americans, we feel that we are unique and have a special purpose, but we have never stopped long enough to define that purpose. The concept of American "exceptionalism" supposes a particular U.S. commitment to democratic values and an obligation to promote those values globally. French analyst Alexis De Tocqueville remarked, "America was a nation of immigrants bound together by shared principles of liberty, equality, individualism and *laissez faire* economics."

The historical uniqueness, values and traditions of the United States is the result of a combination of many factors. Some historians believed that American specialness stems from its political, intellectual and religious heritage and were enduring, while others argued that it would not last.

America exceptionalism stems from the ideals and values of individual freedoms: freedom from tyranny and oppression which our forefathers had lived under for centuries. America presented herself as a land of abundant opportunity - a chance to pursue a new beginning; an opportunity to own property, to worship freely, and to enjoy the benefits of one's labor without fear of government. These ideals were enshrined in the Declaration of Independence and Constitution of the United States, upon which all our civil laws are based. These august documents give Americans a sense of security and of well-being knowing that everyone, even the common man, has a recourse to petition his government for relief.

Another event often cited as a milestone in the history of American exceptionalism is The American Revolutionary War. The best example is found in Thomas Paine's <u>Common Sense</u>. He wrote that, for the first time,

the belief that America was not just an extension of Europe but a new land, a country of nearly unlimited potential and opportunity that was being abused by the British mother country they had outgrown. Although few common Americans would have agreed with them at the time, they laid the intellectual foundations for the Revolutionary concept of American Exceptionalism.

When reading and studying America's founding and heritage, one cannot deny the implicit part religion has played throughout our history. Freedom of religion, in my opinion and study, is the underlying thread that runs through our history. From the Constitution, Declaration of Independence and to most, if not all, of the fifty States' Constitutions, there is some reference to God or Providence. Before the Revolutionary War, Thomas Jefferson wrote, "We devoutly implore assistance of Almighty God to conduct us happily through this great conflict." And near the end of that conflict, he warned, "Can the liberties of a nation be thought secure when we have removed their only firm basis, a conviction in the minds of the people that these liberties are a gift from God?"

Let's never forget the price that was paid to preserve the underpinnings of America's exceptionalism, which is grounded in the Founders, and the founding document they authored, that gives testimony to the religious, and uniquely Judeo-Christian, character of the United States of America.

November 1 Guest Speaker:

Congressman Randy Weber

Congressman Randy Weber is a public servant, proven conservative and successful small business owner representing the 14th District of Texas.

Weber is a member of the Science, Space and Technology committee as well as the House Foreign Affairs committee. He holds leadership roles on both committees: Vice Chair of the Energy subcommittee and Vice Chair of the Africa, Global Health, Global Human Rights and International Organizations subcommittee.

For the past 40 years, Randy Weber has called the Gulf Coast home – a place to start a family and build a business. Although juggling work and family takes great amounts of time and effort, Weber makes time to be an active member of his church and community.

Weber built his air conditioning company, Weber's Air & Heat, in 1981 from scratch and grew his business by using what his grandfather used to call, "good old-fashion Texas horse sense and a strong work ethic." Like others who have successfully moved from business to public service, it is Weber's real-world experience in the private sector that underpins his commitment to lower taxes, his contempt for wasteful spending and his firm dedication to better schools.

Prior to being elected to Congress, Weber served four years in the Texas State House. During his tenure, Weber served on the committees of Environmental Regulation, Public Education, and as Vice Chair of Border and Intergovernmental Affairs.

As the Vice Chair of the Energy subcommittee of Science, Space, and Technology, Randy Weber has been a leader in the effort to unleash the energy industry. On May 22, Weber's first amendment passed the House floor; this amendment incorporates the scientific findings to provide further reason why the Keystone XL Pipeline permits should be approved.

While serving at the Texas House, Randy Weber authored landmark legislation to combat human trafficking and protect women, young girls and boys – some as young as 12 years old. On the House Foreign Affairs committee, Weber is continuing the fight against human trafficking, as well as cosponsoring legislation to strengthen our foreign policies and relationship with our allies across the globe.

As a freshman member of Congress, Weber is committed to advocating for America's job creators and hardworking families. He understands that lower taxes and less government mandates will help relieve taxpayers' tightened purse strings and allow job creators to cultivate and grow their business in a more stable environment.

Weber has lived in a 20-mile radius for over 59 years, and been married to Brenda Weber, a retired schoolteacher, for over 36 years. He is a graduate of Alvin Community College and holds a Bachelor of Science from the University of Houston at Clear Lake. Randy and Brenda have three children and four wonderful grandchildren.

The Galveston County Republican Party hosted several prominent Republicans at their inaugural Hispanic Outreach event held at Barber Middle School in Dickinson on October 8th. Over 60 people attended, including elected officials and several dozen conservative Hispanics from across the county. The evening featured the Honorable David Medina, former Texas Supreme Court Justice, and Judge Debra Ibarra Mayfield,

the first Latina elected to Harris County Court at Law. They were joined by George P. Bush, who is the founder of Hispanic Republicans of Texas.

County Chair Barbara Meeks welcomed everyone and referenced the values that Hispanics and Republicans share: a strong faith, strong family values, protecting the lives of the unborn, a strong work ethic and a desire to prosper. Pastor Rudy Rios gave the invocation and led the pledges to the American and Texas Flags. Gary Polland, former Harris County Republican Chair, served as moderator for the panel discussion.

George P. Bush is a former teacher and attorney and is an officer in the U.S. Navy Reserve. He has worked with a number of non-profits including Big Brothers-Big Sisters, Celebration of Reading in Fort Worth, and the Dallas-based Uplift Education charter system. George P. comes from a long line of conservatives who believe in giving back to their communities.

Judge Mayfield grew up in northeast Houston and attended Aldine High School. She was among the first generation in her family to earn a college degree. Mayfield was quite animated when she told of a recent visit to her childhood neighborhood and reported that she frequently speaks to high school students about the principles that guided her through school. Judge Mayfield is a past president of the Mexican-American Bar Association of Houston.

Justice Medina was born in Galveston and grew up in Hitchcock. His father was in the U.S. Marine Corps and his mother, after her four children were grown, went to college and became a Registered Nurse. It was quite clear that Medina was proud of his Mexican heritage and proud to have grown up in a family that emphasized personal responsibility.

The evening's success can best be measured by the high interest level in forming a Galveston County Chapter of Hispanic Republicans of Texas. A number of Hispanics who attended will meet soon to form the HRT Chapter and reach out to Hispanics across the County.




political speakers informative, but Lesley was able to meet other NFRW leaders and learn more about the national level of the Republican Women's organization.

CONSTITUTIONAL AMENDMENT ELECTION NOVEMBER 5, 2013

- o **Proposition 1** (HJR 62) The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a member of the armed services of the United States who is killed in action.
- o **Proposition 2** (HJR 79) The constitutional amendment eliminating an obsolete requirement for a State Medical Education Board and a State Medical Education Fund, neither of which is operational.
- o **Proposition 3** (HJR 133) The constitutional amendment to authorize a political subdivision of this state to extend the number of days that aircraft parts that are exempt from ad valorem taxation due to their location in this state for a temporary period may be located in this state for purposes of qualifying for the tax exemption."
- o **Proposition 4** (HJR 24) The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of part of the market value of the residence homestead of a partially disabled veteran or the surviving spouse of a partially disabled veteran if the residence homestead was donated to the disabled veteran by a charitable organization.
- o **Proposition 5** (SJR 18) The constitutional amendment to authorize the making of a reverse mortgage loan for the purchase of homestead property and to amend lender disclosures and other requirements in connection with a reverse mortgage loan.
- o **Proposition 6** (SJR 1) The constitutional amendment providing for the creation of the State Water Implementation Fund for Texas and the State Water Implementation Revenue Fund for Texas to assist in the financing of priority projects in the state water plan to ensure the availability of adequate water resources.
- o **Proposition 7** (HJR 87) The constitutional amendment authorizing a home-rule municipality to provide in its charter the procedure to fill a vacancy on its governing body for which the unexpired term is 12 months or less.
- o **Proposition 8** (HJR 147 and SJR 54) The constitutional amendment repealing Section 7, Article IX, Texas Constitution, which relates to the creation of a hospital district in Hidalgo County.
- o **Proposition 9** (SJR 42) The constitutional amendment relating to expanding the types of sanctions that may be assessed against a judge or justice following a formal proceeding instituted by the State Commission on Judicial Conduct.

The Five Categories are:

Membership Development: Includes the recruitment of new members, retaining membership from previous year and having an online presence.

Programs: One of the requirements is to have a representative at TFRW Legislative Day in Austin, as well as having a wide range of guest speakers at regular monthly meetings. Other requirements include reporting on current state or national legislation at meetings and/or in the newsletter.

Campaign Activities: Includes contributing and promoting the election of Republican candidates. Hours accumulated by members for their work on campaign activities count toward the club's overall achievements.

Community Relations/Service: Includes voter registration drives, as well as reaching out to the community in ways such as contributing school supplies, fundraising for Community Service Project, and participating in a Caring for America project.




