Senator Larry Taylor represents Senate District 11, comprised of parts of Brazoria, Galveston and Harris Counties. A native Texan, Taylor attended Baylor University where he received his BBA in 1982. He and his wife Kerri are the proud parents of three children. He owns Truman Taylor Insurance Agency in Friendswood, an independent agency started by his father more than 50 years ago.

Senator Taylor is Vice Chairman of the Senate Business and Commerce Committee and a member of the Senate Education, Government Organization, Health and Human Services, and Intergovernmental Relations Committees. Lieutenant Governor Dewhurst also chose Taylor to represent Texas on The Energy Council; an honor he previously held as a state representative.

Before his election to the Texas Senate in 2012, Taylor served five terms in the Texas House of Representatives. During his tenure, Taylor served as the Chairman of the House Elections Committee, Co-Chairman of the Windstorm Insurance Legislative Oversight Board, a member of the House Insurance Committee, the House Select Committee on Voter Identification and Voter Fraud, the Energy Council, and two terms as Chairman of the House Republican Caucus.

Taylor is proud to have been named a "Taxpayer Advocate" by Texans for Fiscal Responsibility, a "Champion of Free Enterprise" by the Texas Association of Business, and a "Courageous Conservative" by the Texas Conservative Coalition. Locally, he was recognized as Galveston Daily News' "2011 Citizen of the Year" and named "Texas Legislative Champion" by the Sealy and Smith Foundation for his efforts to repair the medical branch after Hurricane Ike.

#### **Voter ID – Where We are and What to Expect**

During the 2011 legislative session the Texas legislature passed SB14 which, once signed by the Governor, required registered voters to show an acceptable form of photo ID at the polls in order to vote regularly. The U.S. Department of Justice (DOJ), acting under Section 4 of the Voting Rights Act, refused to "Pre-clear" this statute and thereby rendered it null and void. Texas and other states took DOJ to court, and in June 2013 the U.S. Supreme Court struck down Section 4 of the Voting Rights Act.



In striking Section 4, they said the requirement for obtaining Department of Justice "preclearance" for changes on how voting is conducted was based on a model from the 1960s and that if "pre-clearance" was to be required, Congress would need to update the law based upon current conditions. The Texas Attorney General subsequently issued an opinion saying the provisions of the Voter ID law are now in play. Although Attorney General Eric Holder has ignored the will of the people of Texas and filed suit in Federal court to block implementation of the Texas Voter ID law, as of now, the Texas Voter ID law is being implemented.

What to Expect: When voting in person you will need to have one of the following current photo IDs:

- Texas Driver's License issued by DPS;
- Texas Election Identification Certificate issued by DPS (available at no cost);
- Texas Personal Identification Card issued by DPS;
- Texas Concealed Handgun Permit issued by DPS;
- U.S. military identification card with a photo;
- U.S. Passport; or
- U.S. Citizenship Certificate containing a photo

If your photo ID has expired, it can still be used, as long as it expired within the past 60 days. Should you arrive at a polling place without one of the above-listed forms of ID, you will be given the opportunity to vote provisionally. If the only reason for voting provisionally is because of your ID, you have six calendar days to go to the Voter Registrar's office to present an acceptable form of photo ID and to fill out the prescribed legal documents stating that you are the same person as the person shown on the voter rolls. If you do this, your provisional ballot will be counted.

#### **Exemptions:**

Disabled: If you are 50% disabled and can verify same from either your Social Security or Veterans Administration records, and if you have no photo ID, then you can apply for an "Exempted" voter registration card. If you provide this form of ID when voting in person you will not be required to show a photo ID.

Religious Exemption: If you have no photo ID, voted provisionally, and have a religious objection to having your photo taken, then you can go the Voter Registrar's office within six days following the election and fill out the appropriate affidavit, and your provisional vote should count.

Natural Disaster: If you have been the victim of a natural disaster declared by the Governor (like Hurricane Ike) and have lost your photo ID, then you can vote provisionally, go to the Voter Registrar's office within six days following the election, and fill out the appropriate affidavit. By doing so your provisional ballot should also be counted.

Voting by Mail: If a person qualifies for a ballot by mail, he or she can vote using this method and, in most cases, do so without having to show any form of identification.

Applications for ballots by mail will not be accepted until 60 days prior to an election and must meet one of the following criteria:

- The voter is 65 years old or older;
- The voter will be out of the county during early voting and on election day (if this is the reason for voting by mail, the voter must have an address outside the county where the ballot can be sent); or
- The voter is incarcerated in jail (these applications will not be accepted until 20 days prior to an election).

I hope this has been a helpful review of the Voter ID requirements. If you have further questions please do not hesitate to call the Galveston County Elections Office at 409-770-5108.
