MICHELLE DRY, COMMANDER, AMERICAN LEGION POST 554 LEAGUE CITY, TEXAS

Michelle joined the Army Reserves in Tuscaloosa, Alabama in 1974 along with her mother. They were the first mother-daughter team to join the reserves. The Army waived the age restrictions for her mother, Beverly, because she had formerly served in the Women's Air Corp (WAC). Her last assignment was in Washington, D.C. where she served in a Military Intelligence Unit and was honorably discharged in

1977.

After her military service, she married and began her family. She now has a total of 12 grandchildren. She has raised one of her grandchildren since he was 18 months old. It was discovered he had serious kidney disease and had to have a kidney transplant. Even though she spent many days at Texas Children's Hospital, she still continued to work.

She's worked as an investment

banker, a facilitator for a training company, a project manager for an air condition/ heating company and is currently the managing partner of an entertainment vending company, Apollo Vending, which has several locations in the Bay Area. Michelle was born in West Virginia, but has been a resident of this area for over She became a 30 years. member of the American Legion in 2006 and has served as an officer for the last three years. She became the first female commander of Post 554 this year. She will be speaking on Women in the Military.
